

Colorado Cannabis Revenue Surpasses \$1 Billion Since Legalization


A brief analysis of the first 64 months of cannabis sales and revenue under Amendment 64

On November 6, 2012, Colorado voters approved Amendment 64, a citizen-initiated ballot measure intended to legalize, regulate, and tax cannabis for adult use. Cannabis officially became legal for adults 21 and older on December 10, 2012, and regulated adult cannabis sales commenced January 1, 2014. Since then, more than \$6.56 billion in regulated cannabis sales have taken place in the state, including more than \$4.46 billion in adult-use sales and nearly \$2.1 billion in medical sales.


Since January 1, 2014, the Colorado Department of Revenue has collected \$1.02 billion in cannabisrelated taxes and fees. This does not include hundreds of millions of dollars in additional cannabisrelated taxes and fees collected by local governments.

From January 1, 2014-June 30, 2017, revenues were derived from a 10% special sales tax on retail sales of adult-use cannabis; a 15% excise tax on wholesale transfers of adult-use cannabis; the standard 2.9% state sales tax on adult-use and medical cannabis sales; and the license and application fees paid by adult-use and medical cannabis businesses. On July 1, 2017, adult-use cannabis became exempt from the standard 2.9% state sales tax, and the special sales tax on retail sales of adult-use cannabis increased from 10% to 15%.


Amendment 64 promised voters that regulating cannabis for adult use would generate tax revenue to benefit Colorado schools. It directed the Legislature to enact an excise tax on wholesale transfers of adult-use cannabis and required the first \$40 million raised each year be deposited in the Public School Capital Construction Assistance Fund. This fund supports the Building Excellent Schools Today (BEST) grant program, which helps to pay for school construction projects. Additional funds raised by this tax are deposited in the Public School Fund.

This excise tax on adult-use cannabis has raised more than \$194 million to support public school construction projects via the BEST grant program. It has produced an additional \$69 million in funds for the Public School Fund. In FY 2018-19, the state began depositing a portion of the revenue raised by the special sales tax on adult-use cannabis in a separate State Public School Construction Fund. Nearly \$20 million has been raised for this fund in the first 10 months of FY 2018-19.




Overview of State Cannabis Revenue Allocation
