

Hemp Cannabinoid Legality Guide

This guide provides a color-coded 50-state overview and detailed explanation of the legality of hemp-derived cannabinoids (Delta-8 THC, Delta-9 THC, CBN, HHC) including cannabinoid limits (such as ratio or limits per serving or per container), product type restrictions (e.g food, dietary supplements, etc.) and age restrictions. Each guide comes with a monthly cover email noting relevant updates regarding legislation, rulemaking, and enforcement.

ALABAMA	Alabama does not have a THC standard for hemp products but allows the sale of hemp-derived "psychoactive cannabinoids" to individuals 21 years and older. "Psychoactive cannabinoids" means "cannabinoids derived from hemp," "including but not limited to," Delta-8 and Delta-10 THC. "Psychoactive cannabinoids" includes all hemp-derived cannabinoids, not just those that are generally understood to be impairing. (Act No. 2023-169 (S.B.66), 2023 Alabama Laws Act 2023-169) (Ala. Admin. Code r. 80-10-2102(21) (2022))	YES - 21+ Anyone who sells, distributes, or markets psychoactive cannabinoids to individuals under 21 years of age is guilty of a Class B misdemeanor.
